Helsinki Stock Exchange

- Historical end of day data from 1987
 - Close, high, low, bid and ask prices, volumes
 - Shares, warrants, subscription rights



Helsinki Stock Exchange

- Intraday data from Helsinki Stock Exchange
 - Price, volume, exact time, broker codes for each trade
 - Data from 1987
 - Shares, warrants, subscription rights



Helsinki Stock Exchange

- All official announcements given by listed firms and HSE
- E.g. interim reports, share issues, splits, cooperation negotiations, corporate acquisitions, big orders...
- Data from 1992



Corporate Governance data

- Corporate Goverance data 2001-2010 from Institutional Shareholder Services
- Rating tool that assists in evaluating the quality of corporate boards and their corporate governance practices
- Rates 5.600 U.S. companies and 2.200 non-U.S. companies



ExecuComp

- Executive compensation data from ExecuComp (from 1992)
- Includes current and historical total compensation, executive options and compensation of industry peers
- Over 37.000 executives, including top officers at over 3.000 companies



Fitch Connect

- Financial data on **banks**, insurance firms, corporates and sovereigns, including 3-year forecast data.
- Financial data includes annual and interim statements, original financial filings and a comprehensive set of ratios, including key regulatory ones.
- This database replaces Bankscope.



Webropol

- Webropol not only collecting data with electronic surveys but also analyzing your own data collected by other means.
- Text mining qualitative text analysis
- Statistics Basic and in depth statistical analysis
 - Basic (t-test, canonical correlation etc.)
 - Variance analyses (ANOVA, correlation analysis)
 - Multidimensional scaling / factor analyses:


