





The students will also learn about corporate transactions, reasons and process of mergers & acquisitions as well as the field of private equity, its different types and the dynamics of the investment process in private equity. The course will strengthen empirical understanding of the subject and enhance the development of critical thinking skills. The written assignment of the course will support writing and analytical skills.
